The Planning and Development Department, Community Planning Division, respectfully requests legislation to amend the Consolidated Downtown DRI's Development Order (D.O.) regarding the "Shipyards" area. The Application for a Change (AFC) to the DRI was submitted on September 27, 2018 by the Downtown Investment Authority, the Consolidated Downtown DRI's "Master Developer". The purpose of the AFC is to amend the development order to increase the geographic area of the "Shipyards" to include Metropolitan Park and Parking Lot J of TIAA Bank Field. The development rights currently dedicated to the "Shipyards" area will not change; the AFC is only proposed to expand the geographic area of the "Shipyards" as identified in the DRI D.O. Additional changes to the D.O. include the removal of all references to "Trilegacy Group, LLC", procedural updates and corrected Manatee Protection Plan references. The changes proposed to the D.O. of the Consolidated Downtown DRI are identified as shown in the Application for a Change attached to this package.
