The purpose of this legislation is to seek City Council approval for an initial Certificate of Public Convenience and Necessity ("CON") for GEL Corporation. In accordance with Chapter 380, Part 1 Ordinance Code, GEL Corporation has applied for an initial "CON" for the operation of a construction and demolition debris and yard trash recycling facility proposed to be located at 4031 North Liberty Street, Jacksonville, Florida. The application has been reviewed by the Public Works Department, the Solid Waste Division, the Environmental Quality Division, the Planning and Development Department and the Florida Department of Health in Duval County and the applicant requirements for operation of such a facility have been met. Final approval of a CON facility is based upon the determination of need for this facility by the City Council. The proposed GEL Recycling Jacksonville construction and demolition debris and yard trash recycling facility is a private facility and the operation of the facility will not require any City of Jacksonville funding. Recycling of construction and demolition debris and yard trash is beneficial to Duval County's recycling goals.






