**Proposed Surplus RE# 073232-0000:** This legislation is necessary for the City Council to declare the subject parcel, "surplus" to the needs of the City, and authorize its sale in accordance with Chapter 122, Part 4, Subpart B, Section 122.423 of the City Ordinance Code. A map of the subject parcel is enclosed for your reference.

This is a 52' x 100' vacant residential parcel located on west 11th Street between Pearl Street and Silver Street. The City acquired the parcel in 1991 and has since conveyed it to Operation: New Hope. Operation: New Hope was unable to construct on the property due to a lack of funding and returned the property to the City in 2016. An interested buyer has asked the City to surplus the property.

The Real Estate Division has conducted an investigation of "need", as required by Section 122.422 and it was determined that the City of Jacksonville has no need to retain the parcel.
