This legislation is necessary for City Council to approve the closure and abandonment of the right-of-way of Setzer Road, established in Official Records Book 1673, Pages 423 and 425, of the Current Public Records of Duval County, Florida. The right-of-way is opened and improved.

The abandonment is requested by Copart of Connecticut, Inc., who owns the adjacent property on each side of the right-of-way, in anticipation of development of the property for use as an automobile shipping and upgrading facility. Closure of the right-of-way will consolidate the applicant's property. The applicant has paid the application fee of \$2,091.00.

There were no objections to the closure of the right-of-way by any City, State or utility agency. The right-of-way contains JEA and ATT facilities. Accordingly, an all utilities and facilities easement will be reserved in the name of the City of Jacksonville and JEA.


