Ordinance No.: 2019-07 **Application for: Normandy Boulevard PUD** 

Dear Honorable Council President Bowman, Honorable Council Member and LUZ Chairperson Schellenberg and Honorable Members of the City Council:

Pursuant to the provisions of Section 30.204 and Section 656.129, Ordinance Code, the Planning Commission ("PC") respectfully offers this report for consideration by the Land Use and Zoning Committee ("LUZ").

- Recommended Planning Commission Conditions\* to the Ordinance: None
  - 1. Dead-end streets, designed to be so permanently, shall be prohibited except when designed as cul-desacs. If T-turnarounds are permitted, they shall meet the minimum dimensions given in the city standard details.
  - 2. All cross accesses to the future commercial parcels shall be a minimum of 250 feet from the edge of pavement of Normandy Blvd. There shall also be a left turn lane into the future parcel on the west side of the entrance road.
  - 3. The subject property shall be developed in accordance with the Transportation Division Memorandum dated January 17, 2019.
  - 4. The maximum building height shall not exceed 50 feet.
  - 5. Prior to the first final inspection verification of substantial compliance within any phase of development, the owner or their agent shall submit to the Planning and Development Department for its review and

approval either (a) an affidavit documenting that all conditions to the development order have been satisfied, or (b) a detailed agreement for the completion of all conditions to the development order.
