PURPOSE: White Paper (Explain Why this legislation is necessary? Provide; Who, What, When, Where, How and the Impact.) The Department applied for and received a LWCF (Land and Water Conservation Fund Program) grant. This legislation would provide permission to receive and appropriate \$200,000 in grant funding from the State of Florida Department of Environmental Protection for public outdoor recreation improvements. The park improvements will include renovation of the splashpad, ADA accessible kayak launch, ADA picnic facilities and additional playground equipment. The improvements will be near the existing picnic area and playground equipment. This park serves the greater Jacksonville area. The City's application for the LWCF grant was submitted for the amount of \$400,000 (\$200,000 reimbursable from DEP and \$200,000 is City's Match). The grant application was approved.

Recommended Action: The Parks, Recreation and Community Services (PRCS) Department respectfully request the authorization for the execution of the DEP Agreement LW676 LWCF Grant Agreement for Kathryn Hanna Park and any amendments to the grant agreement, including time extensions. Funds shall not lapse but shall carry forward year to year until the grant period ends.

The Council finds that the deferral of this amendment of the CIP until the next annual budget and CIP review will be detrimental to the best interests of the community because such deferral will create an unnecessary delay the construction of this recreational infrastructure.


