This legislation is necessary for City Council to approve the closure and abandonment of a portion of the unopened and unimproved right-of-way of East 7th Street established in Plat Book 6, Page 9.

In Ordinance 2007-73-E, the same applicant (Duval Station Landing LLC) submitted an application to close the southerly portion of the same East 7 Street right-of-way to accommodate plans to construct an apartment complex. The applicant is now requesting to close the remaining portion of the unopened, unimproved right-of-way abutting the applicant's property. The applicant's intent is to maintain the area as an aesthetically pleasing buffer for the benefit of their tenants and abutting residential owners. Upon closure, all of the property will revert to the applicant.

There are no utilities within the right-of-way area proposed to be closed; therefore, there were no objections to this request by the City, State and utility agencies.
