This legislation is necessary for City Council to approve the closure and abandonment of Hidden Oaks Lane Right-of-Way established in Plat Book 72, Page 144 of the plat of Waterside (a single-family residential subdivision) as described in the attached Exhibit A.

Hidden Oaks Lane is the lone right-of-way within the gated community of Waterside. The developer/applicant intended Hidden Oaks Lane to be a private road, but erroneously dedicated it to the City of Jacksonville when the plat was recently recorded. This request is to correct the error and make it a private road. This closure will relieve the City of all future maintenance obligations of the right-of-way. There are no City, State or other agency objections to this closure request. An all-utilities easement in the name of the City and JEA will be reserved over the closed right-of-way to accommodate maintenance and repairs of utilities. An easement for ingress and egress will also be reserved for the San Pablo Homeowners' Association, Inc, the association for the development.
