PURPOSE/SUMMARY:

- Please provide the Real Estate Division, on behalf of the Engineering Division, with the authority to request the legislation necessary for the City Council to grant a Conservation Easement to the St. Johns River Water Management District, (SJRWMD) and authorize the Mayor and Corporation Secretary to execute the attached Conservation Easement conveying the subject Conservation Easement to the SJRWMD. This Conservation Easement is for the mitigation of wetlands that will be used in the construction of Segment 3 of the Timucuan Multi-Use Trail System.
- St. Johns River Water Management District Permit No. 40-031-87430-5 allows for the construction of a Multi-Use Trail System within the saltwater wetlands of the Timucuan National Preserve. The subject Conservation Easement relates to the construction of Segment 3 of the Timucuan Multi-Use Trail. The placement of the subject Conservation Easement is over a 7.42-acre portion of the City-owned "Beasley Ttract", which is a condition of the above referenced Permit, as a means to mitigate the construction impacts within the saltwater wetlands.
- The Timucuan Trail State and National Parks are a partnership formed in 1999 between the National Park Service, the Florida Park Service and the City of Jacksonville. The partnership now includes the Nature Conservancy and manages approximately 84,000 acres of unspoiled natural Florida, helping to create one of the largest urban park systems in the nation.
