I. PROJECT DESCRIPTION

Applicant proposes to rezone approximately 5.66 acres of property from PBF-2 to PUD. The parcel is located in the northwest quadrant of 103rd Street and Harlow Boulevard.

The subject property is currently owned by The Episcopal Church in The Diocese of Florida, Inc. and is more particularly described in the legal description attached as Exhibit 1 to this application. The property has current land use and zoning designations of PBF/PBF-2. The property is currently developed for a church. Surrounding uses include: LDR/RLD-60 (single-family), RPI/CO (single-family) and CGC-CCG-1 (car repair) to the west; LDR/RLD-60 (single-family homes), MDR/RMD-D (multi-family) and CGC-CCG-1 (convenience store) to the north; CGC/PUD (vacant) and PBF/PBF-2 (library) to the east; and CGC/CCG-2 (vacant) and MDR/RMD-D (multi-family) to the south across $103^{\rm rd}$ Street.

III. USES AND RESTRICTIONS

A. Permitted Uses:

- 1. Commercial retail sales and service establishments
- 2. Banks, including drive-thru tellers, savings and loan institutions, and similar uses
- 3. Professional and business offices, building trades contractors that do not require outside storage or the use of heavy machinery, ditching machines, tractors, bulldozers or other heavy construction equipment and similar uses
- 4. Hotels and motels
- 5. Art galleries, museums, community centers, dance, art or music studios
- 6. Vocational, trade or business schools and similar uses
- 7. Day care centers or care centers meeting the performance standards and development criteria set forth in Part 4
- 8. Off-street commercial parking lots meeting the performance standards and criteria set forth in Part 4
- 9. An establishment or facility which includes the retail sale and service of beer or wine for off-premises consumption or for on-premises conjunction with a restaurant
- 10. Retail plant nurseries including outside display, but not on-site mulching or landscape contractors requiring heavy equipment or vehicles in excess of one-ton capacity
- 11. Express or parcel delivery offices and similar uses (but not freight or truck terminals)
- 12. Veterinarians and animal boarding, subject to the performance standards and development criteria set forth in Part 4

- 13. Personal property storage establishments meeting the performance development criteria set forth in Part 4
- 14. Retail outlets for the sale of used wearing apparel, toys, books, luggage, jewelry, cameras, sporting goods, home furnishings and appliances, furniture and similar uses
- 15. Essential services, including water, sewer, gas, telephone, radio, television and electric, meeting the performance standards and development criteria set forth in Part 4
- 16. Churches, including a rectory or similar use
- 17. Wholesaling or distributorship businesses located within a retail shopping center (but not on an outparcel or within a stand-alone structure), provided such use is limited to 30 percent of the total gross square footage of the retail shopping center of which the wholesaling use or activity is a part, and further provided there is no warehousing or storage of products not directly associated with the wholesaling or distributorship businesses located on the premises
- 18. Assembly of components and light manufacturing when in conjunction with a retail sales or service establishment, conducted without outside storage or display
- 19. Filling or gas stations meeting the performance standards and development criteria set forth in Part 4

B. Permissible Uses by Exception:

- 1. An establishment or facility which includes the retail sale and service of all alcoholic beverages including liquor, beer or wine for on-premises consumption or off-premises consumption or both
- 2. Permanent or restricted outside sale and service, meeting the performance standards and development criteria set forth in Part 4
- 3. Residential treatment facilities and emergency shelters
- 4. Multi-family residential integrated with a permitted use
- 5. Service garages for minor or major repairs
- 6. Car wash or auto laundry
- 7. Private clubs

- 8. Restaurants with the outside sale and service of foot meeting the performance standards and development criteria set forth in Part 4
- 9. Billiard parlors
- 10. Service and repair of general appliances and small engines
- 11. Schools meeting the performance standards and development criteria set forth in Part 4

C. Limitations on Permitted or Permissible Uses by Exception:

All of the permitted and permissible uses by exception in the CCG-1 district are subject to the following provisions unless otherwise provided for:

1. Sale, service and display, preparation and storage shall be conducted within a completely enclosed building, unless otherwise provided or, and no more than 30 percent of the floor space shall be devoted to storage.

IV. STATEMENTS

A. How does the proposed PUD differ from the usual application of the Zoning Code?

The PUD limits uses from usual Zoning Code application.

B. Describe the intent for the continued operation and maintenance of those areas and functions described herein and facilities which are not to be provided, operated or maintained by the City.

All areas will be maintained by the owner.

V. DESIGN GUIDELINES

A. Lot Requirements:

(1) *Minimum lot area:* None

(2) Minimum lot width: None

(3) *Maximum lot coverage:* None

(4) Minimum front yard: None

(5) *Minimum side yard*: None. Where the lot is adjacent to a residential district, a

minimum setback of 15 feet shall be provided.

(6) Minimum rear yard: 10 feet

(7) *Maximum height of structures:* 60 feet

B. Ingress, Egress and Circulation:

(1) *Parking Requirements*. The parking requirements for this development shall be consistent with the requirements of Part 6 of the Zoning Code.

- (2) *Vehicular Access.*
 - a. Vehicular access to the Property shall be by way of 103rd Street, Harlow Boulevard and Como Road, substantially as shown in the Site Plan. The final location of all access points is subject to the review and approval of the City's Traffic Engineer.
 - b. Within the Property, internal access shall be provided by reciprocal easements for ingress and egress among the driveways of the various parcels of the Property, if ownership or occupancy of the Property is subdivided among more than one person or entity.
- (3) Pedestrian Access.
 - a. Pedestrian access shall be provided by sidewalks installed in accordance with the 2030 Comprehensive Plan.

C. Signs.

- (1) Two (2) double faced or two (2) single faced signs not to exceed seventy-five (75) square feet in area and thirty-five (35) feet in height.
- (2) One (1) street frontage sign per lot (total of 2), not to exceed one (1) square foot for each linear foot of street frontage, to a maximum size of two hundred (200) square feet in area for every two hundred (200) linear feet of street frontage or portion thereof, is permitted provided such signs are located no closer than two hundred (200) feet apart, as provided in the Zoning Code. Such freestanding signs shall be of a monument style or as otherwise approved by the Planning and Development Department, not to exceed thirty-five (35) feet in height, and shall have architectural elements and design consistent with the buildings with which they are associated.
- (3) Wall signs not to exceed ten percent (10%) of the square footage of the occupancy frontage of the building abutting a public right-of-way are permitted.

- (4) One (1) under-the-canopy sign per occupancy, not exceeding a maximum of eight (8) square feet in area per sign, is permitted, provided that any square footage used for an under-the-canopy sign shall be subtracted from the maximum allowable square footage for wall signs on the building in question.
- (5) Directional signs shall not exceed four (4) square feet.

D. Landscaping:

The Property shall be developed in accordance with Part 12 Landscape Regulations of the Zoning Code.

E. Recreation and Open Space:

Water will be provided by JEA. Sanitary sewer will be provided by JEA. Electric will be provided by JEA.

G. Wetlands

Wetlands will be permitted according to local, state and federal requirements.

VI. DEVELOPMENT PLAN APPROVAL

With each request for verification of substantial compliance with this PUD, a preliminary development plan shall be submitted to the City of Jacksonville Planning and Development Department identifying all then existing and proposed uses within the Property, and showing the general layout of the overall Property.

VII. JUSTIFICATION FOR PLANNED UNIT DEVELOPMENT CLASSIFICATION FOR THIS PROJECT

The proposed project is consistent with the general purpose and intent of the City of Jacksonville 2030 Comprehensive Plan and Land Use Regulations. The proposed project will be beneficial to the surrounding neighborhood and community.

- A. Is more efficient than would be possible through strict application of the Zoning Code;
- B. Is compatible with surrounding land uses and will improve the characteristics of the surrounding area;
- C. Will promote the purposes of the City of Jacksonville 2030 Comprehensive Plan.
