PURPOSE/SUMMARY:

- **Please provide the Real Estate Division with authorization to request legislation for City Council approval to close, abandon and/or disclaim a portion of Oak Street and Leila Street, plated, opened and improved rights-of-way in Brooklyn as recorded and established in Deed Book AJ, Page 723, of the Former Public Records of Duval County.**
- **This closure is at the request of the Office of Economic Development and the Jacksonville Transportation Authority. This intersection is part of the Brooklyn area redevelopment.**
- **Ordinance 2007-803-E closed a portion of Oak St. east of the intersection and a portion of Leila St. north of the intersection. Ordinance 2012-703-E closed a portion of Oak Street west of the intersection and a portion of Leila St. south of the intersection.**
- **This closure request has been sent to the various State, municipal and utility agencies which might have an interest in this matter. There were no objections.**
- **An "All Utilities Easement" will be reserved over the closed rights-of-way in the name of the City of Jacksonville and JEA.**
