PURPOSE/SUMMARY:

- Please provide the Real Estate Division with authorization to request legislation for City Council approval to close, abandon and/or disclaim a portion of Dames Point Road, an open and improved right-of-way in Dames Point Replat (Plat Book 28, page 25, dated January 1, 1958).
- The closed roadway will become part of the Intermodal Container Transfer Facility (ICTF) being developed by JAXPORT, the applicant.

- JAXPORT will construct a new section of Dames Point Road to maintain access to all facilities using the current Dames Point Road.

- The applicant, JAXPORT, is a municipal agency and is exempt from paying the application fee.
- JAXPORT owns all the adjacent property.
