PURPOSE/SUMMARY:

- Please provide the Real Estate Division with authorization to request legislation for City Council approval to close, abandon and/or disclaim a Right-of-Way for Drainage established in Plat Book 24, Page 46, Lambing Road Farms, of the Public Records of Duval County, dated July 20, 1953.
- The drainage right-of-way, as established, has never been used. However, there is an open ditch which runs outside of the r-o-w on the adjacent property to the north. This ditch is part of the Lambing Road/No Road drainage system.
- The property owner to the north, Mr. Stephen M. Johns, has dedicated, at no cost to the City, a Drainage Easement (recorded in Official Records Book 16507, Page 268) over the open ditch to replace the right-of-way, which will be closed.
- The applicant, the Engineering Division of the Department of Public Works, has requested this closure to facilitate its drainage project in the Lambing Road/No Road area.
- The applicant is a City of Jacksonville agency and is exempt from the application fee.
- This request has been sent to the various municipal agencies which might have an interest in this matter. There were no objections.
- The adjacent property owner has been notified of the closure application and has no objection to the closures.
