## PURPOSE/SUMMARY:

Fiscal year 2014 required appropriation in accordance with section 932.7055, Florida Statutes. Appropriation of \$210,500 from the Special Law Enforcement Trust Fund to First Coast Crime Stoppers, Inc. (\$25,000), Campus Crusade for Christ, Inc. (\$10,000), The Guardian Catholic Schools, Inc. (\$30,000), Family Farms of Northeast Florida, Inc. (\$40,000), Jacksonville Historic Naval Ship Association, Inc. (\$25,000), The Shannon Miller Foundation, Inc. (\$10,000), Firehouse Subs Public Safety Foundation, Inc. (\$5,000), M.A.D. D.A.D.S., Jacksonville Chapter, Inc. (\$5,500), Community Connections of Jacksonville, Inc. (\$10,000) and Florida State College Jacksonville (\$50,000).
