PURPOSE/SUMMARY:

- The Real Estate Division is requesting the authorization to request the legislation necessary for the City Council to declare the subject tax reverted parcel "surplus" to the needs of the City, and authorize its sale in accordance with Chapter 122, Part 4, Subpart B, of the City Ordinance Code. A map of the subject parcel is enclosed for your reference.
- The subject parcel is a tax reverted 75' x 135' vacant residential lot that reverted to the City on October 11, 2013. The surrounding neighborhood consists mainly of manufactured homes. The parcel is assessed at \$37,125.00.
- The Real Estate Division has conducted an investigation of "need", as required by Section 122.422. As a result of said investigation, the Real Estate Division has determined that no "need" exists for the subject parcel by the City, nor any Independent Agency.
